Adult Passes are valid for one adult. This pass allows access to Public Swim Times and Lap Swim/Water Exercise.

Child Passes are valid for one child and only allows access to Public Swim Times.

**All Season Pass holders must know and follow pool rules, which are posted at the pool.**

**Please be aware of the following rules:**

- ❖ There are no in and out privileges. Once a family member leaves the facility, they may not return until the following day/session.
- ❖ Season passes only allow access to Public Swim and Adult Program\* times. Regular admission fees must be paid if attending any other program at the pool. \*Child passes are not allowed admission to Adult Program times.
- ❖ Passes must be turned into the staff member at the admission window, each time your family visits the pool. If you leave your pass at the pool, family members must check in at the admissions window.
- ❖ Family members who are ages 0-6 or non-swimmers must be accompanied by an adult and the adult **MUST** be within an arm's reach of them at all times.
- ❖ There are **NO** refunds on season passes, for any reason.

**WAIVER/RELEASE**

In consideration for being permitted by Nevada City Parks & Recreation (NCPR) to participate in the above activity, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which may have, or which may hereafter accrue to me as a result of participation in said activity. This release is intended to discharge in advance NCPR (its officers, employees, agents, program providers and program instructors) from any and all liability arising out of or connected in any way with my participation in said activity, though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above. It is understood that this activity involves an element of risk and danger of accidents, including colliding with other swimmers, tripping or falling on the pool deck, exposure to contaminated water and knowingly and freely assume all such risks, both known and unknown. It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold the above persons or entities free and harmless from any loss, liability, damage, cost, or expense, which they may incur as a result of my death or any injury or property damage that I may sustain while participating in said activity.

**PARENTAL CONSENT:** (To be completed and signed by parent/guardian if applicant is under 18 years of age.) I hereby consent that my son/daughter, named above, participate in the above activity, and I hereby execute the above Agreement, Waiver and Release on his/her behalf. I state that said minor is physically able to participate in said activity.
